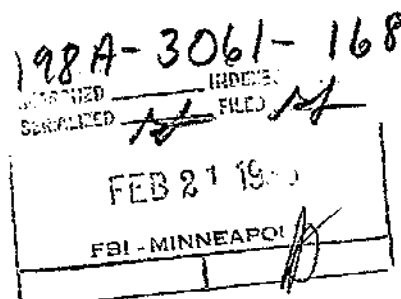

Peltier trying to plead guilty

Frederick Michael Peltier stunned other defendants Tuesday by attempting to plead guilty to failing to report his brother's beating death more than two years ago at Fort Totten, N.D.

Seventeen defendants pleaded not guilty to a variety of charges at their arraignment.

Eleven are charged with first-degree murder. Other charges are perjury, threatening witnesses and failure to report a felony. The charges stem from the Aug. 28, 1983, beating death of Jerome "Eddie" Peltier on the Fort Totten Indian Reservation.

One of the 19 defendants did not appear Tuesday.

U.S. Magistrate Karen Klein, who presided at Tuesday's arraignment, is prohibited from accepting guilty pleas, so Peltier's plea must be presented to a U.S. district judge, who then will pass a sentence. No date was set for that hearing.

Peltier's attorney, H.H. Galloway of Grand Forks, said he advised his client to enter the plea, but he would not say whether a plea bargain had been struck.

"There is no way to avoid calling him as a witness," Galloway said. He added that because other witnesses had been threatened in the case, Peltier probably will be placed in protective custody until he testifies.

But the action surprised many of the other defendants. Jesse Cavanaugh — one of the 11 men accused of murder in the case — uttered an exclamation when Peltier, 20, announced he was pleading guilty, and other defendants fidgeted in their seats.

At least one other defendant in the case was offered a plea bargain. Joel Arnason, attorney for William Fox Jr., 26, said his client refused a deal when it was offered. Like Peltier, Fox is charged with failure to report a felony.

Eddie Peltier, a former Devils Lake police officer, was beaten and run over by a vehicle on Aug. 28, 1983, the prosecution alleges.

In 1983, investigators were suspicious about the death but could find no leads. The case was reopened last fall before Cavanaugh and Loren Grey Bear were indicted on charges of lying to a grand jury in connection

with the killing.

Those two, with seven others at Fort Totten and two in Texas, were charged late last month with murdering Peltier.

U.S. Attorney Dennis Fisher would not say where Frederick Peltier was being held.

The 11 men charged with first-degree murder and assault all entered not guilty pleas Tuesday. They are: Grey Bear, 20, Cavanaugh, 19, Paul Henry Cavanaugh, 20, Tayron "Terry" Dale Dunn, 22, Maynard James Dunn, 24, Timothy S. Longie Jr., 20, Roger D. Charboneau, 29, Dwane Allen Charboneau, 25, Leonard George Fox, 20, Richard John LaFuerente, 27, and John Emmanuel Perez, 22.

LaFuerente and Perez are from Plainview, Texas, and the rest are from Fort Totten. Klein ordered LaFuerente and Perez held without bail until Friday, when she will hear a prosecution request that they be denied bail. The other defendants charged with murder were denied bail earlier this month.

Other charges are:

- Grey Bear, Jesse Cavanaugh, LaFuerente and Perez, threatening witnesses.

- Grey Bear, Leonard Fox, Lisa Greywater, Annabelle Cavanaugh and William Fox Jr., perjury.

- Annabelle Cavanaugh, Bruce Mindt, Kevin Mindt, William Longie Jr. and William Fox Jr., failing to report a felony.

Amanda White Man, who is charged with failing to report a felony, did not appear. Fisher said White Man was arrested in Wolf Point, Mont., over the weekend and will be returned by U.S. marshals.

Jury issues more murder case charges

The number of suspects charged in connection with the 1983 murder of Jerome Edward Peltier stands at 19 following an indictment issued Thursday by a federal grand jury in Fargo.

The grand jury accuses 11 men of Peltier's Aug. 28, 1983, assault and murder and charges eight other men and women on charges of perjury, concealing a crime, threatening and intimidating witnesses.

The 11 murder suspects, charged earlier by criminal complaint, are in jails in Grand Forks, N.D., and Lubbock, Texas. Arrest warrants have been issued for the other eight, some of whom were charged earlier in connection with Peltier's death.

Thursday's indictment is the result of an extended inquiry — still ongoing — by investigators and the grand jury.

"This case has been extremely difficult to investigate because of the fear and intimidation instilled in many witnesses," U.S. Attorney Rodney Webb said. He said investigators with the FBI, Bureau of Indian Affairs, and North Dakota Highway Patrol deserve credit for their perseverance and hard work.

Peltier, a former Devils Lake, N.D., police officer before his death, was found dead on Highway 57 three miles from Fort Totten, N.D., on the Devils Lake Sioux Reservation. According to authorities, the death arose from a drinking party near the home of Bernice Cavanaugh Juarez, the mother of three suspects accused in connection with the murder.

The indictment issued Thursday added the assault charge against the 11 murder suspects and named six additional defendants who are accused of perjury, failure to report the crime, or both. Several of the peripheral defendants already had been charged by complaint.

The 11 charged with Peltier's assault and murder are Leonard George Fox, 20; Timothy Sylvester Longie, Jr., 20; Paul Henry Cavanaugh, 20; Roger Darrel Charboneau, 29; Loren Michael Grey Bear, 20; Duane Allen Charboneau, 25; Maynard James Dunn, 24; Tayron Dale "Terry" Dunn, 22, all from the Fort Totten area; as well as Richard John LaFuente, 27; and John Emmanuel Perez, 32, both of Plainview, Texas.

In addition, Grey Bear was accused of perjury and threatening three witnesses; Jesse Cavanaugh was accused of threatening five witnesses; LaFuente was accused of threatening a witness; Perez was accused of threatening a witness; Leonard Fox was accused of perjury.

Lisa Greywater was accused of perjury and failure to report the crime; Frederick M. Peltier, the victim's brother, also was accused of failure to report; William Fox was accused of perjury and failure to report; Annabelle Cavanaugh, the Cavanaugh brothers' sister, was charged with perjury and failure to report; William Napoleon Longie, Jr. was accused of failure to report; Bruce Mindt and Kevin Mindt, brothers, were accused of failure to report; and Amanda White Man was accused of failure to report.

Mystery shrouds brutal murder

PORT TOTTEN, N.D. — When they found Eddie Peltier's body, his face was so swollen, his body so bruised, even his father didn't recognize him.

Investigators initially suspected he was the victim of a hit-and-run driver.

His battered body was found on Highway 57 three miles from Fort Totten, a scenic drive along the hilly Devils Lake shoreline. The discovery was made at 6 o'clock the morning of Aug. 28, 1983, by a carload returning to town from a late-night party.

One of those in the car was James Yankton, a police officer on the Fort Totten Indian Reservation who was off-duty. But police couldn't find anyone who had witnessed the accident.

Capt. Bill Byram of the North Dakota Highway Patrol, who arrived at the scene later, was puzzled by what he saw.

For one thing, there was the distance between the spot where the body was found and tire marks on the highway. Too great a distance for a hit-and-run accident, he thought. The body would have been badly disfigured, maybe even dismembered, if it had flown that far from the impact.

Then there were the bruises — all over his body, different sizes, different shapes. A sudden death would prevent bruising, he thought, because a stopped heart wouldn't produce bleeding from tiny blood vessels.

Tracks also indicated two vehi-

cles were involved. To Byram, it didn't look like a highway accident. It looked like murder.

But he had to convince his fellow officers they were dealing with a homicide. "It was a little too gruesome to get people to believe," he says.

Sgt. Ron Ziegler of the Devils Lake police was stunned when he matched the fingerprints on the body with those of his former colleague and police academy classmate, Eddie Peltier.

Jerome Edward Peltier had joined the Devils Lake, N.D., police force Dec. 1, 1977, as a young recruit. Eighteen when he started, he was too young to legally drink in the bars he sometimes had to check while on duty.

But the kid impressed his fellow officers. He took pride, almost fanatical pride, Ziegler says, in the

uniform. His boots always shined, his shirts never showed wrinkles. He dealt with the public well, say officers who knew him.

And as an American Indian, Peltier was a valued addition to the police force in a predominantly white town so close to the reservation.

They remember him as a good athlete, a guy who outclassed the other cops on the basketball court. He didn't mix much with other officers off-duty. Most of the time he played ball and associated with his buddies from the reservation.

He had a wife and a son. In 1976, he married Kristi Ellen Burt, a white woman from Devils Lake. Because Eddie was 17, his parents had to sign papers approving the marriage. Marcus Benjamin Peltier was born later that year. The marriage ended when Eddie sued for divorce in 1978.

The following year, after 18 months as an officer, Eddie resigned. Officers who were interviewed can't remember why he left the department. He served on the Cooperstown (N.D.) Police Department for six or eight months, then left.

He dabbled for a while in a three-man band that played top 40s rock and roll, and a little country and western. Eddie played the bass guitar and sang lead vocals. The band was called Eternity.

At the time of his death, Eddie was 24 years old, looking for work and \$1,800 behind in his child-support payments.

Ziegler says it is a shame Eddie left police work. "For a guy his age, I think he was doing awfully well," he said. "If he would have had another three or four or five years, I think he would have made an excellent officer."

The answers were all about the same. "I don't know." "I wasn't there." "I was too drunk." "I don't remember."

More than a year after Eddie's death, investigators still weren't close to an arrest. Every lead led nowhere.

The investigation determined there was a beer drinking party near the home of Bernice Cavanaugh Juarez, who lived up the hill from where the body was found. It was one of several parties in the area the night of Aug. 27, 1983.

The FBI, Bureau of Indian Affairs police, the North Dakota Highway Patrol, Devils Lake police and the Benson and Ramsey county sheriff's departments cooperated in the investigation.

must have been painful. They certainly were brutal.

And according to his younger brother, Fred, they must have been terrifying.

A short time after his brother's death, when he was first interviewed by investigators, Fred Peltier said he was at Eddie's apartment in Devils Lake the evening of Aug. 27. Four others, including Jesse Cavanaugh, were also there.

They all left the apartment early that night, bound for Fort Totten. Their car was having mechanical problems, and finally the group parked on an approach along Highway 57 near a service road called Ski Jump Road. Fred said he knew little of what happened while they were there because he fell asleep. Eventually, they got a ride to the home of a friend, Tim Longie, where Fred spent the night, he said.

More than two years later, on Dec. 27, 1985, Fred Peltier was interviewed a second time. He denied being at Juarez's house the night of his brother's death. Later that day, however, Fred Peltier admitted to investigators that he was at the Juarez residence the night of the murder.

He said there had been a drinking party. He said he had broken up a fight between Jesse Cavanaugh and his brother. There was a lot of yelling and cussing, and there was a fight on the road, he said.

Then, on Dec. 30, the day before the mass arrest, Fred Peltier told an investigator he had watched as a mob beat his brother to death.

Fred Peltier's admission corroborated statements given by DeMarce and two brothers, Kevin and Bruce Mindt, who also say they witnessed the beating.

DeMarce said the fight progressed in stages, beginning in the area near the Juarez home and continuing down Ski Jump Road to the highway.

Assailants pounded Eddie Peltier with fists, feet, two clubs and a set of martial arts weapons called numb-chucks. Eddie managed to break away, the Mindt brothers

Eddie's parents decline requests for interviews. "There hasn't even been a trial," John Peltier tells a visitor. "Come back when the trial's over, and I'll tell you whatever you want to know."

Pictures of the eight Peltier children and grandchildren adorn a living room wall in the Peltier home. Underneath hangs a folded American flag.

Lawrence Joshua, a tribal judge and Eddie's cousin, says the family was shocked when Fred was arrested for failing to report his brother's murder.

"I think the folks didn't even know he was there," Joshua says. "I think they were as much surprised as I was."

Besides Grey Bear, Cavanaugh and LaFuerce, those charged with Eddie's assault and murder are Paul Henry Cavanaugh, Jesse's brother, their cousin, Timothy Sylvester Longie, Jr., Tayron Dale Dunn and Maynard James Dunn, brothers; Roger Darrel Charboneau and his nephew, Duane Allen Charboneau, who was Eddie Peltier's brother-in-law; Leonard George Fox, and John Emmanuel Perez, LaFuerce's brother-in-law.

In an indictment returned last week by a federal grand jury in Fargo, Jesse Cavanaugh also is charged with threatening five witnesses; Grey Bear is charged with perjury and threatening three witnesses; LaFuerce is charged with threatening a witness; Perez is charged with threatening a witness, and Fox is charged with perjury.

Besides Fred Peltier, others charged with failure to report the crime are Lisa Greywater, also accused of perjury; Annabelle Cavanaugh, the Cavanaugh brothers' sister, also charged with perjury; William Roland Fox Jr., Leonard Fox's cousin, also charged with perjury; the Mindt brothers, and Amanda White Man.

Besides the allegations of brutality associated with the crime, people on the reservation are shocked by those who are purportedly in

they tried to track down cars spotted in the area. Juarez says she heard screeching tires and the sound of a car driving off at about 6 a.m. But she didn't hear a fight or any party noises.

Police found no witnesses. Nobody saw what happened.

John Peltier, Eddie's father, a former BIA cop, was frustrated by the lack of progress. After about a year and a half, the FBI closed its case for lack of evidence.

"People just didn't want to cooperate for some reason," Byram said. "They had information, but they didn't want to say anything."

Last August, the authorities got a big break. A young woman named Patricia DeMarce stepped forward and told police she had seen what happened to Eddie Peltier.

She told police, according to court records, that she and her husband were told they better keep their mouths shut. "There's a lot of us, and we will all get you," DeMarce says she was told.

The threats were made in late October. About a week later, a federal grand jury indicted two men, accusing them of trying to thwart the investigation. Jesse Dean Cavanaugh, Juarez's son, was charged with two counts of intimidating witnesses. Loren Grey Bear, son of the BIA police captain on the reservation, was charged with perjury and failure to report a felony.

In the next several weeks, three more people were charged with failure to report Peltier's death. Step by step, the authorities were applying pressure on those they were convinced knew something, but weren't talking.

Documents filed in court made it clear investigators were getting closer to finding the killers. More than 100 people had been interviewed, some of them several times. Still, it was almost two and a half years since Peltier's death, and nobody had been arrested for murder.

Dec. 31, 1985, New Year's Eve. noon. Three six-man teams of heavily armed officers swept through Fort Totten, arresting eight men for the murder of Jerome Edward Peltier.

An ambulance was standing by, just in case.

Neighbors watched from doorsteps and windows as lawmen took them away. There were no incidents, but relatives complained the police had used an unnecessary show of force.

Another man was arrested on his way back to the reservation from Devils Lake. Within 70 minutes, nine suspects were in custody. Two days later, two more men were arrested in Plainview, Texas.

said, and the attackers chased him on foot, yelling, "Get him, don't let him get away."

They caught Eddie on the highway and he pleaded with his attackers for mercy, his brother said. But they went on hitting him.

"I heard my brother yell, 'Someone please help me' and 'Please let me go,'" Fred Peltier said. "Eddie was screaming for help and from pain."

DeMarce said she watched from a distance of 60 feet as two men dragged Eddie onto the highway and Ricky LaFuenta got in his small truck and drove over the body. And then drove over it again.

The Mindt brothers quoted Grey Bear and Cavanaugh as saying, "Nobody saw or heard anything that happened tonight."

Fred Peltier said Cavanaugh told him, "Don't ever talk about what happened to Eddie or you will get the same thing."

□

The death certificate said Eddie Peltier died at about 8 a.m. Aug. 28, 1983, from multiple injuries, including a broken neck, a crushed skull and broken ribs on his left side.

Nobody is saying why he was killed.

Some people speculate that Eddie made enemies when he was a police officer. Some might have found him to be perhaps too diligent in enforcing the white man's law against his fellow Indians.

Sgt. Dallas Carlson, who served alongside Peltier on the Devils Lake police force, said Eddie was efficient at making arrests from the warrant list. The warrant list is a list of suspects with arrest warrants pending against them.

Peltier wasn't the first Indian cop in Devils Lake, though. Joe Chaske, now a tribal judge, served six years with the Devils Lake police, and another six years as a BIA cop.

And he isn't the last. Peter Belgarde is an Indian from the reservation, currently on the Devils Lake force.

Both men say they never had problems with Indians expecting lenient treatment from a fellow Indian. "That's an idocy," Belgarde says of suggestions Eddie made enemies on the reservation because of his race. "No, I don't agree with that at all."

Others suggest Eddie might just have been at the wrong place when tempers flared.

VOICED

Relatives of the accused say many of the defendants didn't get along with one another. There was feuding among some of the families. They find it difficult to believe the suspects got together at a party — impossible to believe they combined to commit murder and to enforce a conspiracy of silence that lasted two years.

Carl McKay, chairman of the Devils Lake Sioux Tribe, says he was surprised to learn of some of the names of the defendants. Some came from respected families and weren't known as troublemakers, he says.

Leonard Fox and Grey Bear, for instance, once attended the North Dakota School of Science at Wahpeton to study police science. They dropped out in the fall of 1933 after being questioned by the FBI about Peltier's death, says Alvina Alberts, Fox's grandmother.

Reservation residents are anxious for the case to be resolved, the questions laid to rest.

Juarez, who describes herself as a born-again, spirit-filled Christian, says there wasn't a party in her yard. And there wasn't a fight, she says. She says her son, Paul, and daughter, Anabella, were at home the night of Peltier's death, and Jesse was staying at his uncle's home. She says the whole case against her sons is a fabrication. She contends witnesses were forced into incriminating others. "It's all lies," she says. "It's the work of the Devil."

The status of Grey Bear's father, Melvin Grey Bear, captain of the BIA police on the reservation, isn't clear. Richard Wilkie, acting captain, says Grey Bear was put on special assignment in Utah in October. Donald Morgan, BIA superintendent for the reservation, says Grey Bear has been on sick leave since last month. No action has been taken to remove him, but Morgan thinks it would be a good idea for Grey Bear to take a leave of absence until his son's case is resolved.

The investigation, meanwhile, is continuing. Nineteen people have been indicted in connection with the murder. Dennis Fisher, assistant U.S. attorney and leading prosecutor in the case, says more arrests are possible.

There is tension in some circles, mostly among families purportedly involved in the murder as participants or witnesses. Juarez has temporarily moved out of her home, which is isolated and lacks a telephone. Last week, Leonard Fox's younger brother Lee reported he was shot at while walking at night along Highway 57, Alberts says.

"People are scared," Joshua says, "and we shouldn't live that way. This is supposed to be the United States."

9 appear in murder case, more arrested

Bond was denied Thursday for nine Fort Totten, N.D., men charged in the Aug. 28, 1983, murder of Jerome "Eddie" Peltier on the Fort Totten Indian Reservation.

U.S. Magistrate Karen Klein ordered the nine to be held without bond, all on second-degree murder charges. The decision came at about the same time that two other suspects were being arrested in Texas.

The nine are identified as Loren Grey Bear, Jesse Cavanaugh, Terry Dunn, Maynard Dunn, Timothy Longie Jr., Dwayne Charboneau, Roger Charboneau, Paul Cavanaugh and Leonard Fox.

The two others, Richard LaFuerite and John Perez, wanted in connection with the murder, were arrested in Plainview, Texas, shortly after the hearing began in Grand Forks. Plainview police Capt. Bill Mull said LaFuerite and Perez walked into the police station after the police mistakenly picked up Perez's brother, also named John, on the arrest warrant.

Mull said Perez, 32, and LaFuerite, 27, both of Plainview, wanted to know why the other Perez was arrested. They were arrested and turned over to the FBI. It is not known if the two will be brought to North Dakota to stand trial with the rest, Mull said. The John Perez originally arrested was released, Mull said.

If convicted, the defendants face a potential maximum sentence of life in prison.

continued. The two are accused of perjury before a grand jury and threatening witnesses in connection with the Peltier investigation. They were charged in November.

Shirley Ann Greywater, 19, Fort Totten, pleaded not guilty later Thursday to a charge of perjury and failing to report a felony in connection with Peltier's murder. No date was set for trial.

During the hearing for the nine, FBI Agent Spencer Hellekson testified that he considered the case to be closed until September when he received information that led to the arrests.

Hellekson testified that he was told by witnesses that a fight began during a party at the Cavanaughs' mother's house on the reservation. When Peltier, a former Devils Lake police officer, tried to escape the fight, others chased him on foot and in vehicles, Hellekson said. Peltier was caught on North Dakota Highway 57 near Ski Jump Road, and was beaten with fists, feet and two clubs, he said.

Hellekson testified that Peltier was held on the highway by three of the suspects while a vehicle was driven over him. He was left in the road and found by a police officer about an hour later.

Witnesses told Hellekson they felt threatened by statements made by Jesse Cavanaugh and Grey Bear, which is why no one came forward for two years. Hellekson testified that because of the threats made in the past, the nine should not be released on bond.

A preliminary hearing was set for Jan. 10 to determine if there is sufficient evidence to bind the nine over for trial.

Defense attorneys had requested the nine be released on bond after the mother of the two Cavanaughs testified. Bernice Juarez said there was no party at her residence that night and if there had been a fight there, she would have heard it.

11 charged in Fort Totten murder

Eleven men have been charged with the murder of a former Devils Lake, N.D., tribal police officer more than two years after he was brutally beaten to death.

Six three-man teams of heavily armed lawmen arrested all but two of the suspects without incident Tuesday for the Aug. 28, 1983, murder of 29-year-old Jerome Edward "Eddie" Peltier.

Dennis Fisher, assistant U.S. attorney in Fargo, said warrants are out for the other two men, former residents of the Fort Totten (N.D.) Indian Reservation now living in Texas.

The murder charges, filed late Monday afternoon in U.S. District Court, follow a lengthy grand jury investigation in which five people were indicted earlier for withholding information, perjury, or witness tampering.

One of those arrested earlier for failing to report or prevent the murder was the victim's younger brother, Fred Peltier, 20, Fort Totten, who reportedly witnessed the beating.

Court documents indicate investigators had to penetrate a wall of silence put up by witnesses who said they feared they would be murdered if they cooperated with authorities.

Those charged with the murder are: Loren Grey Bear, Jesse Cavanaugh, Terry Dunn, Maynard Dunn, Timothy Longie Jr., Ricky LaFuerite, John Perez, Leonard Fox, Dwayne Charboneau, Roger Charboneau, and Paul Cavanaugh.

LaFuerite and Perez, both of Plainview, Texas, remained at large late Tuesday afternoon. The other suspects live on or near the reservation, Fisher said.

At least four people witnessed the beating and identified the suspects, according to an affidavit filed by FBI special agent Stephen

Helekson of Grand Forks, N.D.

An apparent break in the case came Monday, when Fred Peltier said he stood by and watched as the gang beat his brother after an all-night drinking party.

Witnesses said the suspects beat Eddie Peltier with fists, feet, two clubs, and a set of martial arts weapons called "numb-chucks" — then dragged him onto Highway 57, where he was run over twice by a light pickup truck.

"I heard my brother yell, 'someone please help me' and 'please let me go,'" Fred Peltier said in court documents. "Eddie was screaming for help and from pain.

"It seemed like a long time, maybe 10 minutes, before Eddie stopped yelling and screaming and Eddie was quiet and the beating stopped."

Two other witnesses, brothers named Kevin and Bruce Mindt, said they saw three of the suspects chasing Eddie Peltier on foot, yelling. "Get him, don't let him get away."

Fred Peltier said Grey Bear and Jesse Cavanaugh came up to him after the beating and said, "This did not happen." A week later

Jesse Cavanaugh threatened him, saying, "Don't even talk about what happened to Eddie or you will get the same thing."

Helekson's affidavit didn't suggest a motive for Peltier's murder. The victim had been a tribal police officer for 1½ years, but wasn't an officer at the time of his death.

As many as 40 people were at the drinking party, which was held in the yard of Jesse Cavanaugh's mother, Bernice Cavanaugh Juarez, on the reservation.

Fisher said the investigation is continuing.

Asked if there will be further charges, he said: "The other shoe hasn't dropped yet. There will be a full accounting."

The suspects are being held and are scheduled to make their initial court appearances Thursday, the same day Grey Bear's trial for perjury and failure to report a felony is to begin.

Grey Bear's father, Melvin Grey Bear, has taken a leave of absence as a tribal police officer.

Nine charged in Fort Totten murder case

Nine men were arrested Tuesday and charged with murder in connection with the 1983 death of a former Devils Lake police officer. The men, in their late teens and early 20s, are from the Fort Totten Indian Reservation and Devils Lake area.

About 30 law enforcement officers participated in a two-hour house-to-house sweep that netted eight of the suspects. One was arrested later Tuesday near Devils Lake. Authorities are searching in Texas for two other men believed to be involved in the case.

Fisher. He said Bureau of Indian Affairs agents used a map to show the location of the suspects' homes. They conducted a trial run with the map before traveling to the homes in 10 cars.

"It was a coordinated sort of thing," Fisher said. "Many of the houses were in a local area."

Jerome "Eddie" Peltier was found dead Aug. 28, 1983 on the Fort Totten Indian Reservation. He had been beaten repeatedly and run over twice by a vehicle on state Highway 57 south of Devils Lake. His body was found three miles from Fort Totten near the home of the Cavanaugh's mother, where a beer party had been held the night before.

The victim's brother, Frederick Peltier, told authorities Monday he'd witnessed the murder. Frederick Peltier was arrested Friday night on a charge of "misprison of felony" — knowledge of a felony but failure to report it, according to the Fisher.

Loren Grey Bear, Jesse Cavanaugh, Terry Dunn, Maynard Dunn, Timothy Longie, Jr., Dwayne Charboneau, Roger Charboneau. Paul Cavanaugh and Leonard Fox are scheduled to appear on first-degree murder charges before Magistrate David Kessler at noon Thursday in Grand Forks. Federal arrest warrants were issued in Texas for Ricky LaFuenta and John Perez for the same murder.

The heavily armed law enforcement officers met no resistance as they rounded up the suspects, according to Assistant U.S. Attorney Dennis

In an affidavit filed in U.S. District Court, Frederick Peltier said an altercation broke out at the party between Eddie Peltier and Jesse Cavanaugh, and escalated into a fight involving the other accused men.

Peltier said he witnessed the men chasing Eddie down the highway and he observed them beating his brother with fists and clubs. Frederick Peltier's affidavit quotes him as saying, "I heard my brother yell, 'someone please help me' and 'please let me go.' Eddie was screaming for help and from pain."

Then, Peltier said, "It seemed like a long time, maybe 10 minutes, before Eddie stopped yelling and screaming and Eddie was quiet and the beating stopped."

Peltier's affidavit corroborates eyewitness accounts filed in the original complaint, which states the men chased Peltier down and repeatedly beat him with fists and clubs as he screamed for help, Fisher said.

The affidavit states the men then dragged Peltier out to the road and

dumped him into the path of LaFuenta's truck. Fisher said it is not known if Peltier was dead at this time. LaFuenta is accused for driving his truck over the body and backed up over it again.

Peltier's affidavit states his vision was obstructed, but he heard the car tires screech twice and knew the vehicle had run over his brother. Grey Bear and Jesse Cavanaugh told him, "This did not happen."

About a week later, Peltier said Cavanaugh threatened him by saying, "Don't ever talk about what happened, to Eddie or you will get the same thing."

The complaint says after the murder, Grey Bear threatened witnesses by saying, "No one saw or heard anything."

Fisher said he does not know why the fight had broken out, but that it could have had something to do with Eddie Peltier's brief stint as a Devils Lake police officer. Peltier worked for the department for about a year in the late 1970s, according to Herald files.

Grey Bear and Cavanaugh were charged Nov. 6 with lying to a federal grand jury and threatening a witness in the investigation of the case. Cavanaugh is charged with two counts of witness tampering. Grey Bear was charged with perjury for lying to the grand jury about not seeing Peltier the day before he was murdered.

Shirley Ann "Beasley" Greywater also was indicted Dec. 10 on perjury charges and concealing a felony for lying to the grand jury about the murder.

FBI Special Agent Spencer Hellekson said FBI agents cooperated with U.S. marshals, the North Dakota Highway Patrol under the command of Capt. William Byram of Devils Lake, Ramsey County Sheriffs Department, Devils Lake Police and Bureau of Indian Affairs officers in apprehending the suspects.

Fisher says he will ask the court to deny bail for the suspects.

Nineteen people were indicted Thursday in connection with the 1983 beating death of a former policeman on the Fort Totten Indian Reservation, officials said.

Court documents said 11 men killed Jerome Edward Peltier, a former Devils Lake policeman, after a beer party on the reservation near Fort Totten. Peltier was beaten and thrown in the path of a pickup truck that ran over him twice, court documents say.

The 25-count federal grand jury indictment charges 11 men with first-degree murder and assault. Eight other men and women were charged with perjury, neglecting to report the attack and threatening and intimidating witnesses. The 11 men accused of murder are in custody in Grand Forks, N.D., and in Lubbock, Texas.

"This case has been extremely difficult to investigate because of the fear and intimidation instilled in many witnesses," U.S. Attorney Rodney Webb said yesterday.

Charged with murder and assault are Leonard Fox, 20; Jesse Cavanaugh, 19; Timothy Longie Jr., 20; Paul Cavanaugh, 20; Roger Charboneau, 29; Loren Grey Bear, 20; Duane Charboneau, 25; Maynard Dunn, 24; Tayron (Terry) Dunn, 22; Richard LaFuernte, 27, and John Perez, 32.

LaFuernte and Perez, in custody in Texas, are to appear at an extradition hearing there today, officials said.

Grey Bear also was accused of lying to the grand jury and threatening three witnesses. LaFuernte and Perez were charged with threatening witnesses and Fox was accused of perjury.

Frederick Peltier, the victim's brother, was among those charged with neglecting to report the death. He told officials of his brother's death on Dec. 30, saying he had kept silent for more than two years for fear of retribution from the attackers, court documents say.
